



CYCLING CANADA TRADE TEAMS 2026

1.0 Registration Process

The 2026 registration process will be hosted on CCN again. Teams can submit their applications [on CCN here](#). Please submit everything all at once on CCN as it will ensure that none of your documents get lost. If you are having difficulties uploading your documents, please contact tradeteams@cyclingcanada.ca and we would be happy to work out a solution.

Some forms will need to be submitted as a **Zip Folder**. You can learn how to make of these [here](#) (PC) or [here](#) (Mac).

Payment will be processed through CCN, which will have a processing fee. If you wish to pay using a physical cheque please contact us to coordinate, and we will provide you with a code to bypass the payment and which will allow you to submit the registration.

Please have all of your team documents ready to upload before beginning the process.

2.0 Trade Team Definition

A Trade Team is an incorporated or registered organization whose purpose is to promote itself, its sponsors and/or members through cycling events.

Typically, riders would enter into a contractual relationship with the team / business in order to outline matters of mutual expectation and compensation.

Cycling Canada (CC) affiliated Trade Team must be formed by a group of athletes in the Junior, U23 or Elite categories. A maximum of 50% of the team may be comprised of Master riders. Riders can participate for the same team in all cycling sports. A minimum of 75% of the team must be comprised of Canadian riders.

Note to teams: A Trade Team name must be different from your club name; a rider who is not on a trade team should have a different team name reflected. The difference does not need to be large but must be distinct. Eg. "Canadian Cycling Club Racing" vs "Canadian Cycling Club". The jersey should be different in some way to reflect this difference.



Who is a staff: All team staff and regular volunteers should be noted in the registration package. Requirements were determined based on [Cycling Canada's Screening Risk Matrix](#); Cycling Canada reserves the right to require additional documents beyond what is outlined in the matrix. An overview can be found in the table below; additional details can be found under Required Documents.

3.0 Services & Support

It is a priority for CC to continue to develop policies, programs, and services to support trade teams. CC is making a concerted effort to encourage affiliation by providing a direct communication link to support and facilitate the related administration of these teams. CC will be able to provide affiliated CC and CC/UCI Trade Teams with the following services:

- Access to participation statistics of national events;
- Notification about invitational competition opportunities forwarded to CC by other cycling federations and international organizers;
- A copy of CC companion guide to the current UCI regulations;



- A 36 meter square technical space allocated at National Calendar events site – (electricity, water and security at the cost of the team); 55 meter square technical space at Canadian Championships and Canada Cup races;
 - Trade team visibility must be approved by CC staff; not applicable at major multi-sport events
- Posting of the Trade Team on the “Cycling Canada Trade Teams” page of CC website;
- As a registered Cycling Canada Trade Team you have access to CC special rates from [official sponsors and partners](#). For more details contact josh.peacock@cyclingcanada.ca;
- Mention of the Trade Team on the official results list during National events;
- Allowed to enter a car in the caravan at Elite and Junior Canadian Road Championships;
- The team manager will have one free access to the Caravan Driver online course (Road) (value of \$25);
- Cycling Canada will cover up to two staff members to receive a background check (value of \$50). Contact tradeteams@cyclingcanada.ca for access;
- Registration for MTB world cups done directly through CC;
- Publication of CC Trade Team Canada Cup Ranking;
- CC Trade teams will receive priority invitation to national calendar events, over clubs;
- 2026 Calendar will be shared with the teams at the same time it is shared with Provincial / Territorial Cycling Associations;
- A free premium/preferred space in the Team Expo area;
- Access to use our donations platform for team fundraising purposes;
- Affiliation as a registered team or club within team’s “home” province or territory;
 - This might include additional benefits that vary province to province

4.0 CC Trade Team Quotas

A Cycling Canada Trade team must:

- Have a minimum of 4 riders total;
- Have a maximum of 24 riders total;
- Be comprised of no more than 50% Master riders;

There are no minimums per age category or for number of men/women on a team. **When selecting their rosters, Trade Teams should carefully consider the events they plan to participate in and any team composition requirements that they may have.**

Cycling Canada strongly recommends that the team have both male and female staff. This helps align with the [Rule of Two](#), which is considered to be best practice.

6.0 Application Instructions

Please use one team registration form per team. Be sure to indicate which disciplines you will be participating in using the checkboxes within the registration form. This should also be noted on the athlete list.

One fee per team wearing identical jersey, for all cycling sports, category or gender.

Additional fee applies for different jersey.

Example:

Identical jersey +	Same owner +	Track Team and Road Team	1 fee
Different jersey +	Same owner +	Track Team and Road Team	2 fees



7.0 Required Documents

See checklist of items on [registration package](#).

Required items for newly registering teams only:

- Copy of the **business registration documents** with provincial and federal authority (*to verify the existence of a legal administrative and financial structure supporting the team*).
- **Official team logo** (JPEG or PNG)

Items for all registering teams:

- **Before registering, all teams are encouraged to connect with the Cycling Canada office on a call. This will ensure all processes are followed smoothly.**
- **Registration fee** payable to CC for the amount of \$850 plus \$47.00 processing fee (1 per team per unique jersey, no matter what the sport, category or gender).
- [Team registration package](#) (1 per team in each sport).
- **Official team logo** (JPEG or PNG; *if updated since previous registered season*)
- Copy of the **team jersey artwork** (JPEG) (front of the jersey – 1 per team in each sport)
- Proof of **valid third-party liability insurance** (minimum recommended coverage per occurrence: \$5,000,000) – 1 per team in each sport
 - Liability insurance can be purchased from Cycling Canada.; [click here](#) to learn more on this process. This insurance is only available to national level teams. If the team already has secured insurance, please provide CC with a Certificate of Insurance.
- Copy of **each riders' contract** (confidential to CC). Contracts signed virtually must be completed with a verified signature (Ex. DocuSign, SignNow) or by hand and scanned/pictured. All contracts must include the anti-doping wording included at the bottom of this document.
- Copy of **UCI license from select team members**: owners, staff, and non-Canadian riders. UCI ID's for all team members must be included in the registration form.
- **All Canadian staff and riders must complete [the CCES Clean Sport Untracked module](#)** each season they register; to be submitted in a Zip folder through CCN.
 - There is space in the registration form to indicate if a team member has completed this requirement for the season as part of another project.



Safe Sport Requirements – Read carefully

- **Mandatory CCES Safe Sport Training for ALL Riders and Staff.** All members of a Cycling Canada UCI Team must complete the CCES Safe Sport module and associated signature. Teams are responsible for ensuring their members complete the form; members cannot be recognized as being part of the team until this agreement is signed. **This form only needs to be completed once and is valid indefinitely upon signing.** To complete, follow the directions on [this document](#).
- **Mandatory NCCP Safe Sport Training for ALL Riders and Staff.** [The NCCP Safe Sport Training module](#) developed by the Coaching Association of Canada will help everyone involved in sport identify and prevent situations on maltreatment (This is a free module). ALL Riders and Staff will need to provide their NCCP numbers to check Safe Sport Training completion at registration. Safe Sport Training is **valid for 3 years**
 - If there is a Safe Sport equivalent in a rider or staff's country of residence this will also be accepted.
 - Non-Canadian riders and staff can register for a Locker account through the Coaching Association
 - **Despite the similar name, this module is separate from the CCES Safe Sport requirement listed above**
- **Background Check for all staff;** background checks must be completed every three years
 - [Background checks can be completed here](#); background checks should be accompanied by [Application](#) and [Disclosure](#) forms.
 - Contact tradeteams@cyclingcanada.ca to be set up with the two included background checks
- **Individuals who have submitted a background check previously within the last three years will be asked to provide a [renewal form](#)**



8.0 Registration

The team will be officially registered when all documents have been received. There will be no exceptions. Files submitted past the deadline will incur a \$250 fine.

A memo will be circulated to all Provincial/Territorial Association offices advising them of the affiliated status and naming the team members. This will facilitate the licensing process under the registered name of the trade team. Your affiliation as a Cycling Canada Trade Team will also act as affiliation with your local Provincial/Territorial association; this may provide additional benefits to the team.

10.0 Policies:

Riders that want to race another discipline:

If a member of a Cycling Canada Trade Team wants to race in a discipline in which their team is not currently registered, they must race as an individual (in a plain jersey).

UPDATE: Riders may request to guest ride with another Canada Trade Team or club team if their original team is not participating in an event. To be considered for approval, a form signed by the rider and both teams must be submitted.

Guest Riders and Staff

Guest riders and staff can only be added to teams in specific circumstances. A guest staff may join a team for up to two weeks (14 days).

A trade team can add a temporary rider to their roster if the following conditions are met:

- They have a waiver from their current club/team (Covered in guest rider form);
- Insurance coverage is sufficient
- The team must submit, along with the [Guest Rider form](#):
 - Rider contract
 - [Certificate of completion of the CCES Clean Sport Untracked](#)
 - [Completion of CCES Safe Sport module](#)



A trade team can add a temporary staff to their roster if the following conditions are met:

- Insurance coverage is sufficient
- The team must submit, along with the “Guest Rider” form:
 - [Certificate of completion of the CCES Clean Sport Untracked](#)
 - [Completion of CCES Safe Sport module](#)
- Background check and the appropriate Application, Disclosure or Renewal Forms

If a guest wishes to join with the team for a longer period of time or on multiple occasions, they must also complete [the NCCP Safe Sport module](#). Requests to add a guest are not guaranteed and should be submitted a minimum of two weeks before the event. Cycling Canada will work collaboratively to support the development of riders.

Remove/Add rider or staff:

- When a member is removed from the roster, the “Remove Team Member” form must be submitted. A signature is needed from the team and the team member;
- When a member is added midway through the season, the team must submit the same documents for the individual as they would have at the beginning of the season.

*During the season, no rider already registered with a CC/UCI team for the current season may join another CC/UCI team outside the transfer period from **1 June to 15 July** (except cyclo-cross riders).

A rider who has not previously been registered with a CC/UCI team can join a team at any time during the year, as long as their contract finishes at the end of the season. The provincial association or club may request an official release.

Each CC/UCI team is permitted to add 2 trainee riders under 23 to its team, between 1 August and the end of the year subject to the following regulatory conditions below:

- The rider may not previously have ridden for a CC/UCI road team
- The CC/UCI team must notify Cycling Canada of the identity of the riders before August 1st
- Such riders shall obtain the authorisation of their national federations and may be associated with only one CC/UCI team during this period
- Upon authorisation of his new team, a trainee rider may continue to participate in events of his club team.



All rider contracts must contain the following text:

As an athlete on a Cycling Canada Trade Team, I will:

- comply with the anti-doping rules of the UCI, IOC, IPC, CCES and Cycling Canada, including submitting to announced and unannounced doping control testing when required by the NSO, UCI, CCES, WADA or any other agency authorized to conduct testing;.
- complete the CCES online anti-doping courses as required by the Cycling Canada, CCES, and/or Sport Canada, as applicable;
- participate, if asked by Cycling Canada, in doping control and/or education programs exclusively when they have been developed in co- operation with Sport Canada and the CCES;
- abide by the CADP as administered by the CCES;
- refuse to enter into any relationship with a coach, support staff or person who the Athlete knows is under sanction by the NSO, the IF or an anti- doping agency for a doping-related offence;
- not use banned substances that contravene the rules of the IOC, IPC, IF or the CADP; and
- not supply such substances to others directly or indirectly, nor encourage or condone their use by knowingly aiding in any effort to avoid detection.
